

Dixon's Distilled Spirits' Village Media eNewsletter Signup Contest Rules & Regulations

Eligibility

- Giveaway is open to all residents of Ontario.
- There is no purchase necessary to enter; the entrant must have agreed to sign up to receive Dixon's Distilled Spirits newsletters.
- Documentation to support winners' identity will be required in order to demonstrate legal drinking age (19 years old in Ontario).
- Giveaway is not open to individuals associated with the giveaway, including employees of Dixon's Distilled Spirits or their immediate family.

Details

- To be eligible, contest entrants must sign up for Dixon's Distilled Spirits eNewsletter by completing the entry form in its entirety at <https://dixonsdistilledspirits.com/emailsignup/> on or before 11:59 p.m. EST on July 1, 2023.
- Two winners will be drawn from accumulated entries three (3) business days after entry closes: Jul. 5, 2023.
- In order to earn an entry into the draw, an entrant must sign up/agree to receive the Dixon's Distilled Spirits eNewsletter.
- Winners will be drawn from qualifying participants and notified by Dixon's through email direct message. A winner will have 48 hours to respond/accept the prize and provide an appropriate Ontario mailing or delivery address. After 48 hours, the winner will be declared forfeit and a second draw completed.
- Although it is anticipated that the prize package will be delivered to a winner no later than two (2) weeks following the draw, delays may occur due to couriers and postal operator delays.
